Zonta Club of Hilo's Strangulation Bill Signed Into Law

Gov. David Ige signed SB 1037 on July 2, 2019. The bill was introduced by the Zonta Club of Hilo and sponsored by Hawai'i State Sen. Lorraine Inouye.

This bill strengthens the language in the domestic violence statute on strangulation.

In attendance for the signing were U.S. Sen. Mazie Hirono, a founding member of the Women's Legislative Caucus; Heather Kimbell, Zonta Club of Hilo advocacy chair, and members of the Hawai'i Women's Coalition.

SB 1037 amends the offense of abuse of family or household member by amending the type of physical abuse that constitutes strangulation to include blocking the nose and mouth or applying pressure to the chest. The bill also clarifies that infliction of a visible bodily injury is not required to establish the offense.

"We were very pleased this bill passed in its first year," said Kimbell. "The most pervasive and least recognized human rights violation worldwide, gender-based violence affects women and girls of every race, class, culture, ethnicity, age and country. Strangulation and suffocation present serious health risk. Yet, strangulation often leaves no external physical evidence."

Just a short update on the child marriage laws in D9 with a shout out to Delaware and New Jersey for being the first states to ban child marriage.

How sweet and short but impactful:

"(a) No individual under the age of 18 shall be granted a marriage license." Delaware House Bill No. 337

New Jersey AB865 amended its marriage law by stating that no license will be issues to parties under 18 years of age.

AZ – As of April 2018, lawmakers passed HB206 to end marriage before 16. Under the new law, 16 and 17 year olds can marry if they have parental consent or are emancipated and there is no more than a 3-year age difference between the couple.

CA – In September of last year California state senators passed SB273. This law allows children under 18 years of age who *meet certain requirements and obtain a court order and parental consent* granting permission for the underage person to enter into marriage or a domestic partnership. This law met with much push back from certain non-profits and the ACLU.

HI – The minimum age to marry is 18; but children 16 years old or older can marry with judicial approval and children 15 years old can marry with judicial approval *and* parental consent. The minimum age with parent consent is 16, without parental consent – 18 years of age. §572-1(2), 572-2. The Legislature has not yet introduced a bill toward ending child marriage.

NV – AB139 was passed in June 2019 that allows 17 year olds to marry with parental consent and judicial approval. It also allows for consideration as to whether the marriage is in the minor's "best interest".

UT – Representative Angela Romero introduced in February 2019, HB 234 to end child marriage in Utah. The bill was thereafter weakened to include exceptions that still allow 16 and 17 year olds to marry. This bill passed the House and the Senate and signed into law in late March 2019. Representative Angela Romero intends to submit additional legislation that will raise the age to marry.

CAMPAIGNING POLICY: ALERT TO ALL ZONTIANS!

Campaigning is defined as <u>encouraging voters</u> to vote for or <u>discouraging voters</u> from voting for a specific candidate, who is on the slate or nominated from the floor.

Zontians will not use membership lists or act in any other way to contact other Zontians for the purposes of lobbying for or against proposals that will be voted on, or for or against nominations for office or candidates who are running for office, at international conventions, district conferences or other Zonta meetings.

Zontians who are attending a district conference or area meeting at which elections are held may confer with other members to discuss the candidates, but they may not instruct delegates how to vote.

Examples of Activities that are not Permissible

- Visit, by a candidate to club meetings, area meetings or district conferences with no purpose other than to promote her own or another person's candidacy.
- Using culture, ethnicity, age, religion, sexual orientation or geography to influence votes.
- Distributing at any time any gift, trinket, button, or other promotional material by or on behalf of a candidate.
- Advocating or discouraging the election of a candidate in club, area or district communications, irrespective if this communication is oral, written or through any social media.
- Zonta leader, club or an individual Zontian instructing a voting member/s how to vote. This includes so called block voting or directions to vote for a particular candidate/s.
- The use of social media to promote or discourage support for a candidate.

MOTIONS, MOTIONS, MOTIONS

Motions, motions, motions. There are main motions, secondary motions, and motions to return a previous motion already considered or voted upon back to the floor for re-consideration. There is also a ranking of motions - the order in which motions are to be considered or can be made. Of the three main categories of motions referenced above, secondary motions take precedence, or priority, over the other two. Hence, if there is a main motion on the floor for discussion and a voting member introduces a secondary motion, action on the main motion is suspended until the secondary motion(s) is(are) addressed.

There are three types of secondary motions: subsidiary motions, privileged motions, and incidental motions. Subsidiary motions propose to take some action on the main motion, such as to amend a motion. Privileged motions are unrelated to the main motion but generally are urgent matters to address before continuing with the business meeting; for example, raising a question of privilege garding some factor effecting the participation of members, such as the temperature in the room or volume of the speaker, must be addressed before returning to the business in process when the privileged motion was first made. Incidental motions address procedures; they may propose to change a procedure or point out a violation of procedure, such as moving to suspend the rules or object to an action that is against the rules (point of order). Of the secondary motions, incidental motions must be dealt with immediately, followed by privileged motions, and then subsidiary motions. After secondary motions have been addressed, you can return to the main motion that was originally on the floor.

As you are climbing the ladder of motions, just remember that the main motion is on the floor - when you climb up the rings of motions, you must descend before hitting the floor (main motion) again. Now you are equipped for the district conference!
